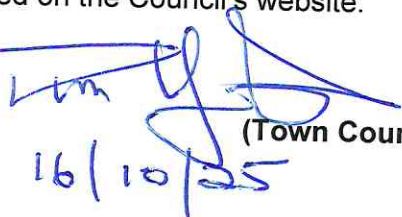
(iv) fail to declare an interest that I acquire after the date of this register and have to declare
